# FROM THE **CEO**

FROM THE **BOARD CHAIR** 

hink Together was founded 25 years ago from a need to provide a safe and welcoming place for children and youth to receive academic support.

For more than two decades, Think Together has worked side by side with education leaders across California to grow our services from its humble beginnings as a single afterschool center in Costa Mesa funded solely by the generosity of our earliest donors to the state's largest nonprofit provider of expanded learning programs serving close to 200,000 students.

While there's much to celebrate, there's also much to reflect on and respond to. There's a deepening divide of outcomes for students. Those hit hardest by the COVID-19 pandemic —mostly lower-socio-economic individuals and families—are lagging even further behind academically and feeling the mental-health and social-emotional effects.

This divide was made clear when results from the National Assessment of Educational Progress (NAEP), often called The Nation's Report Card, revealed that two out of three students did not meet state math standards, and more than half did not meet English standards on state assessments taken in the spring of 2022.

**Yet, there's hope.** As California has grappled with the impacts of the pandemic, it has also increased its investment in education and supports including plans for universal expanded learning. Previous funding served about 15% of the students at a typical school. In the new environment, all students will have access. This implies a growth of six times current program levels just at schools we currently serve!

To meet this moment, we need the same kind of village of supporters from Think Together's earliest days to bring

their ingenuity, creativity, and resources to continue the growth trajectory, enhance program quality, and recruit and retain the best talent for our young people. Together we can forge ahead with renewed hope and determination in our work with schools to change the odds for kids.

s I reflect on the three years in which I had the opportunity to lead Think Together's board, it's been a whirlwind of activity. In the fall of 2019 we launched a strategic planning initiative with the pro bono support of Boston Consulting Group. In the midst of that process, we acquired the expanding learning division of the nonprofit organization, Youth Policy Institute, which had suddenly closed its doors. The acquisition saved programs for 10,000 students as well as 450 jobs.

In March 2020, the pandemic hit and schools closed. With no idea of what the future might bring, we needed to respond with new supports for our communities.

Think Together also recently completed the acquisition of Orenda Education, which trains school leaders to improve the academic performance of their school systems. Now, with a grant from the U.S. Department of Education, Orenda Education is turning its data-driven school improvement methodologies into software tools in order to scale its impact.

Why are we doing all of this work? Pre-pandemic, only about half of California's 6 million students were performing at grade level, whereas 2 million students were—by any definition—struggling academically. In response to this, the Think Together board created a moonshot goal to close this gap—a vision we call Project 2 Million. We know there are examples of schools and districts that have closed these gaps, and we believe that Think Together can help replicate and scale these bright spots so that no child is left behind.

As you think about your time, talent, and treasure and how you might invest those valuable resources to make the world a better place, I would encourage you to join us at Think Together in our journey to change the odds for vulnerable kids. My life has been greatly enriched by my time being involved here, and I bet yours will be, too.

# A YEAR IN REVIEW





This past year, Think Together celebrated 25 years of impacting students. Established as a nonprofit in 1997, the organization has grown from one volunteer-run program to serving 200,000 students in more than 500 schools throughout the state. Over the past 25 years, the organization has supported an estimated two million students throughout their education journey.

### **Now Hiring!**


Over the past year, staffing became a top priority for Think Together. With new state grants helping to serve more students, the need to hire and train more Program Leaders to run expanded learning programs increased. Coupled with the challenge of statewide staffing shortages for all industries, Think Together invested in a new Talent Acquisition department to source, recruit, and hire quality applicants.

## **School Improvement Division**

Think Together fully acquired school-improvement organization Orenda Education, formerly an affiliate of Think Together, to provide long-term sustainability and scalability for Orenda's data-driven, equity-focused approach for educators. Now a Think Together division, Orenda was recently awarded a \$4 million Education Innovation and Research grant by the U.S. Department of Education to digitize and distribute its school-improvement approach through an online platform to reach educators throughout the United States and impact more students.

# **Expanded Learning Opportunities Programs**

Two years of pandemic-disrupted learning continued to negatively affect student performance in school. California lawmakers allocated additional funding and identified expanded learning organizations to provide the academic, social, and emotional support that students need. This historic funding allowed more students to be served for more days per year and more hours per day than ever before.



## **Project 2 Million**

Think Together continues to envision a state where the two million students who are currently not meeting grade-level standards receive the academic support they need to prepare them for college and a fruitful career. Although the pandemic has intensified this challenge, this year's exciting developments, including Expanded Learning Opportunities Programs grants, universal pre-kindergarten, and Orenda Education's digitized platform, are steps toward transforming our vision into reality.



For 25 years, there has been an undercurrent of our original motto still coursing through our daily work: Teaching, Helping, Inspiring, Nurturing Kids—Together.

# OUR FOCUS AREAS

Our mission is to partner with schools to change the odds for kids. We do this by providing academic and enrichment support in the following focus areas:



## **EARLY LEARNING**

Think Together's Early Learning programs promote school readiness for children from birth to 5 years of age. Programs include early literacy, early math skills, preschool, and parent education.



## EXPANDED LEARNING

Expanded learning programs wrap around a student's typical school day to provide academics, enrichment, physical fitness, and social-emotional support. Programs include after school programs, summer (and other non-instructional days), and tailored student support services. Programs are free of charge for families.



## SCHOOL IMPROVEMENT

Orenda Education is Think Together's school improvement division, partnering with schools' teachers and leadership teams to close the achievement gap and improve student outcomes, such as mastery of English-language and math curriculum, increased graduation rates, and college readiness.



## **Early Learning**

Think Together's Early Learning programs provide the youngest students and their families with the tools and skills they need to start their academic journey with success. Programs include state preschools, parent academies, Learning Link, early literacy and math programs, Read for the Record, and Raising a Reader.



# WHAT'S NEXT FOR THINK TOGETHER

## **Statewide Staffing Solution**

Think Together is leading the way to create solutions to support California's increased need to hire qualified individuals to run critical expanded learning programs. Think Together is partnering with school districts, colleges and universities, and the top talent-acquisition professionals in the United States to form a Staffing Collaborative. This collaborative will enable expanded learning providers to hire the staff that is needed for universal expanded learning across the state, fulfilling California's investment in educating today's students.

## **Accelerate Learning**

The pandemic amplified the need for students in underserved communities to have access to enrichment programs. These vital programs—which take place during afterschool hours and spring and summer breaks—provide the additional education, exploration, and enrichment that are essential for students to learn new skills and discover their passions. Think Together is forming key partnerships to offer enrichment "accelerators" in the arts, STEM subjects, and sports statewide. Accelerator pilot programs will begin in select schools by spring 2023.

Imagine an education system where all students master grade-level curriculum each year and graduate high school ready for college. Think Together's school-improvement division, Orenda Education, has a proven approach to empower systemic changes within school systems to accelerate student learning and close the achievement gap. Orenda will be leveraging a \$4 million Education Innovation and Research grant from the U.S. Department of Education to digitize and distribute their approach through an online platform. Soon, teachers and school leaders across the nation will have free access to tools, training, and modules that can improve student outcomes and impact the academic success and lives of students.



## New Opportunities Will Expand Early Learning

California has adopted Universal Prekindergarten; by 2026, all 4-year-olds in the state will have access transitional kindergarten in public schools to better prepare them for school success. Think Together is now supporting school districts with before- and after-school programs designed specifically for these young students.

Additionally, Think Together Early Learning has been awarded more than \$2 million for General Child Care and Development (CCTR) grants with the California Department of Social Services. Our goal is to provide contracted sites with a comprehensive and cost-effective system of childcare and development services for children 0 to 3 years old and their parents.




